By signing this release and indemnity, I hereby:

1. Voluntarily agree to participate in the BMW Motorrad Rider Demonstration Test Ride (the “Test Ride”) conducted by BMW Motorrad, a division of BMW Canada Inc.;
2. Confirm that I am at least 19 years of age and confirm that the above driver’s licence is valid;
3. Confirm that I am an experienced motorcycle rider for the purposes of the Test Ride and that I have read and understood the Test Ride rules and regulations* (see Appendix A on reverse);
4. Acknowledge that the Test Ride can be dangerous, particularly under conditions created for the Test Ride, including variations in the road conditions or the actions of other Test Ride participants, and may result in injury or death;
5. Accept all risks of injury, loss, damage or liability arising out of or in any way relating to the Test Ride, whether such injury, loss, damage or liability results from my actions, the actions of another Test Ride participant or the actions of a BMW Motorrad employee or agent;
6. Release BMW Canada Inc. and all of its divisions, its employees, agents and contractors and all persons and companies, which sponsor it, or the Test Ride, and all persons involved in the provision of the Test Ride (collectively, “BMW”) from any and all liability for loss, damage or injury caused or contributed to by BMW or in any way arising out of the Test Ride, whether arising out of contract, common law or statute law;
7. Acknowledge that during the Test Ride, and while at any location at which the Test Ride is being conducted, I shall at all times follow the directions of the designated BMW Motorrad representative or agent;
8. Agree to indemnify, and keep indemnified, BMW from and against all loss, damage, injury or liability (including liability for costs) caused by or contributed to by me or in any way arising out of my acts or omissions, including but not limited to any of my actions which fall outside the rules and regulations established by BMW Motorrad and its personnel;
9. Acknowledge that during the Test Ride, BMW is not responsible for items and personal property left unattended by you; and
10. Confirm that BMW Canada Inc. is the owner of the motorcycle hereby assigned and that I have been given BMW’s authorization and permission to use and operate the assigned motorcycle for evaluation purposes during the Test Ride.

By signing below, I acknowledge having read and understood the terms and conditions of this Waiver of Liability, and agree to be bound by the terms and conditions herein and acknowledge that I may be waiving certain legal rights by doing so.

APPENDIX 'A'

*Test Ride Rules and Regulations:

1. The Test Ride will be conducted as a group ride. You must remain with the group at all times and return with the group.
2. During the Test Ride, follow only the route led by the designated group leader. Never overtake the group leader unless specifically instructed to do so.
3. Ride according to the rules of the road and always observe and abide by the posted speed limits, designated road signs, etc.
4. In the event of any uncertainty regarding the Test Ride or if you have any questions pertaining to the assigned motorcycle, consult the designated group leader or other group participant and, if mobile, pull over and stop **ONLY** when it is safe to do so taking into consideration the safety of all group participants.

A \$30 Donation to the Alberta Children's Hospital is required at time of booking to ensure commitment.
